## 6. PUBLIC APPEARANCES

#### SCHEDULED PUBLIC APPEARANCE

- Gloria Regensberg, Tempe, re: Airport, spoke on behalf of QualiTe, a group of concerned citizens working together to improve the quality of life for everyone in Tempe. The group has been working together on Tempe neighborhood and Phoenix Sky Harbor (PSH) issues since 2003.
  - She thanked Council for the initiation of a Request for Qualifications for a future study of noise measurements near the air port noise monitors. Actual measurements are critically important.
  - QualiTi recommended that the City become familiar with a feasibility study by PSH regarding

non-residential sound mitigation. The Cook College and Theological School and ASU Community Services Building are scheduled to receive mitigation, but Lamson Adult College, Police Training Facility, and Lighthouse Christian Fellowship are not.

Mayor Hallman asked for the basis in determining that those properties do not qualify for sound mitigation.

Ms. Regensberg stated that she would research the qualifications.

- Safety is a primary concern. Airports and the FAA concentrate on safety for airplanes and passengers. QualiTe is concerned with safety of the people on the ground. PSH is ranked as one of the nation's most dangerous airports, but the FAA claims that PSH runways are among the safest in the nation. The City should support the safety of its citizens on the ground.
- Ms. Regensberg thanked Council for initiation of the study of air quality of the property west of Priest and north of Rio Salado Parkway to determine its suitability for outdoor sports activities.
   An air quality assessment is an appropriate and prudent move. Factual information regarding impacts from PSH has not been adequate.
- QualiTe supports Council's vision for Papago Park and supports the recreational use of the park, keeping the park as an open space in tribute to the great civilization that once inhabited the grounds there.
- QualiTe recommends that the City work with PSH to be a good neighbor. The "good neighbor" language was removed from the rewrites in the 1990's and Congressional reauthorization of airport programs is currently pending. The "good neighbor" policy should be reinserted in the federal legislation.
- PSH and the FAA have failed to meet commitments to Tempe. Promises were made to Tempe in exchange for the third runway and few, if any, have been kept. QualiTi recommends that Tempe lobby our congressmen for language and programs that will benefit residents as well as community facilities impacted by PSH. QualiTi urges Tempe and Phoenix to work together.
- She thanked Council for its service to the City, and for their responsiveness to noise measurements and air quality concerns.

Mayor Hallman clarified QualiTi recommendations:

- Examine air quality
- Determine why PSH is excluding some Tempe properties from noise mitigation.
- Authorize Congressional reauthorization of airport programs, including the "good neighbor" program. Examine the promises made to Tempe in the IGA in 1994, and determine the extent to which those are being upheld.
- Seek help from Congressional delegation on aviation issues

## 7. CURRENT EVENTS/COUNCIL ANNOUNCEMENTS/FUTURE AGENDA ITEMS

 Councilmember Arredondo commended Shelley Hearn for the extra effort she provided during the recent Senator McCain rally.

- Councilmember Carter added that the Mayor received a letter from Senator McCain following the event to announce his bid for the Presidency. The Senator wrote, "It could only have been accomplished by the best Tempe has to offer. Please let them all know that it meant a great deal to me to be able to announce my campaign for President of the United States in the same wonderful city in which I began my career twenty-five years ago." She also commended Ms. Hearn.
- Councilmember Mitchell congratulated Marcos de Niza and McClintock High Schools for winning two State Baseball championships, and Tempe High for becoming runners-up in State Softball.
