6. PUBLIC APPEARANCES

UNSCHEDULED PUBLIC APPEARANCE

Aaron Finter, Counsel for Valley Express Towing. Valley Express Towing was not awarded the contract (#49), and although they have no objection to the process, they object to the lack of participation with Valley Express Towing in the process. The City requested that the towing companies submit bids. They did submit a bid. There was never a contract at that point, but the City requested that the companies resubmit bids and this was timely done. At that point, they learned that the City intended to make public the initial bids from the other towing companies. They did submit a letter objecting as they believe that ran afoul of Arizona statutes pertaining competitive bidding. Following that letter, there was never any type of inspection of the facilities of Valley Express Towing. That is important in determining who would be awarded the contract, and is also important because there was a change in the facilities (an expansion) between the time of the initial bid and the resubmitted bid.

Mayor Hallman asked the City Attorney that since this item has already been approved, whether it would

be acceptable to engage in conversation.

Mr. Ching responded that to the extent it was not a public hearing item, it is a little more questionable. If a councilmember had pulled it for consideration, he would feel more comfortable, but he spoke with this gentlemen and because they have filed a protest timely, their protest will be handled pursuant to the City's Procurement Code. That process is already in place. He believed that if Council wants to engage, it is probably within the spirit of the open meeting law since it was on the agenda.

Mayor Hallman asked if there was a view of the facilities after the first submittal.

Mr. Finter responded that there was an inspection following the initial submission. He continued that none of the references listed with the resubmitted bid were ever contacted. If there was no inspection of the facilities and no contact with the references, perhaps Valley Express Towing was not allowed to be a part of that process. They don't object to the award, but they perceive a lack of fair consideration.

Mayor Hallman clarified that there are three issues being raised: (1) the bids were made public; (2) there was no review of the facilities in the second iteration of the process; and (3) none of the references were contacted.

Mr. Ching verified that this is proceeding through the administrative process.

Mayor Hallman asked what kind of damages result from having the bids made public.

Mr. Finter responded that it is pursuant to Title 28.

Mayor Hallman clarified that it would be whatever the statute would require, but there are no specific damages in this case.

7. CURRENT EVENTS/COUNCIL ANNOUNCEMENTS/FUTURE AGENDA ITEMS

- Councilmember Carter announced that the Arizona State Supreme Court has awarded the Tempe Municipal Court the award for the category of improving communications and cooperation with the community, other branches of government, and within the judicial branch. The Tempe Municipal Court was nominated for its Tempe Municipal Court's Community Connect Project. She further noted a photograph showing City Manager Charlie Meyer in a kayak, and she also congratulated Councilmember Shekerjian who will become a grandmother.
- Councilmember Arredondo commended the Police Department for their saturation of an area of Tempe that statistically showed that it lowered crime rates. It says a lot of about the leadership, about the people who wear the uniforms, and about how serious we are about crime in Tempe. He added that Eugene, Oregon, is using a Tempe model for the marketing and recruitment outreach committees that we formed. The Diversity Department's leadership under Rosa Inchausti has shown that diversity is much more than just color. He further explained that he left the dias during the Issue Review Session because GPEC, SACA, and Orbit need the full attention of council or the new

council. All Tempe deserves a full council on those three things.

- Councilmember Shekerjian announced that she attended the opening of the South Mountain Community College satellite campus in Guadalupe. It was a great example of partnerships between a non-profit organization (the Boys and Girls Club), the Town of Guadalupe, and South Mountain Community College. They have worked hard for many years to form that partnership and open the campus. She also thanked the Neighborhood Services staff. Recently, there has been construction in south Tempe, and Shana Warner and Elizabeth Thomas have listened to the community concerns regarding noise, and have been very responsive. Elizabeth Thomas went out at 2:30 a.m. with a police officer to listen firsthand to how noisy it was and there have been efforts to mitigate some of the negative effects.
- Mayor Hallman stated that on the agenda this evening there were many change orders for contracts. He asked the City Manager to assemble a team to review how the City is controlling contracts. When this many change orders come through, it is time to look at how we are handling contract management and whether or not change orders should be awarded for a project. He also appreciated Councilmember Arredondo's earlier point. The meeting date was changed from June 12th to June 5th to accommodate a councilmember's vacation and then ultimately things changed. Clearly, there is a lot of work to be done. Fortunately, the GPEC item did not get approval, but it was moved back to the Formal agenda. Otherwise, it had been on the Formal agenda for tonight, but he had asked that it be removed so that the public could be alerted and the Council would have the one opportunity to address the Ad Hoc Long Range Budget and Finance Planning Committee's recommendation. The SACA grants do not involve City money, but it is money that has been awarded by the City of Tempe through prior policy decisions to the Tempe Community Council (TCC). His understanding was that the TCC was merely looking for Council direction on their recommendations. In terms of the Orbit, the final decision that we move forward and that staff will return with recommendations on how to change the program was appropriate.

Meeting adjourned at 8:15 p.m.
