**Agenda Item 2: Minutes from September 17, 2007 Meeting**

**Agenda Item 3 – Child Crisis Center**

**Oralia Gracia-Alinea** provided the following information on the Child Crisis Center -East Valley Family Resource Center and resources provided to grandparents who are raising their grandchildren:

- 1) The new Family Resource Center will open for services in January 2008 and is located at 917 N. Country Club Drive in Mesa. The Family Resource Center is a project of the Child Crisis Center-East Valley. The existing center is located at 170 W. University Drive in Mesa.
- 2) A variety of parenting classes and resources are provided at the Family Resource Center including the following free grandparent/kinship services:
  - Monthly grand-parenting/kinship support group for caregivers raising their relative's children.
  - Guardianship workshops that provide assistance from a paralegal who specializes in grandparent/kinship parenting issues, as well as other workshops with experts who provide information on how to get medical assistance, school enrollment benefits and financial support for grandchildren.
- 3) While services are available for Tempe parents and grandparents currently there are no Tempe residents involved in the grandparent/kinship services.
- 4) **Lynette Stonefeld, Communities for Schools** and the parent and community liaisons from Tempe Elementary School District will be visiting the Family Resource Center on October 20<sup>th</sup>. Arrangements will be made for Ms. Garcia-Alineas to meet with the liaisons and provide information on the available grandparent/kinship services so this information can be passed on to parents, grandparents, and guardians in Tempe..
- 5) **Jan Pagoria, ASU** will provide a link to the Child Crisis Center on ASU resources for parents.
- 6) Ms. Gracia-Alineas also provided information on the Central Arizona Kinship Coalition and events that it sponsors:
  - An annual Grandparents Day at the Ballpark will be held and 500 tickets will be distributed.
  - The 9<sup>th</sup> Annual Grandparent & Kinship Caregiver's University will be held on Saturday October 20, 2007. The topic is "Navigating the System."

**Agenda Item 4 –Communities for Kids**

**Lynette Stonefeld, Tempe/Kyrene Communities for Kids** provided the following updates:

- 1) The City has again been selected again as one of the 100 Best Communities for Youth by America's Promise for Youth. Councilmembers Mark Mitchell and Onnie Shekerjian, Tempe Community Council Executive Director Kate Hanley and Lynette will attend the award presentation in Washington, D.C. this month. America's Promise for Youth has requested that Lynette present on the Family Resource Centers located in Tempe elementary schools.

- 2) Lynette is completing the 2008 100 Best Communities for Youth application for the City of Tempe. It is due on October 25<sup>th</sup>. She needs two youth testimonials on how programs or services in Tempe have helped them.
