**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPE,  
ARIZONA, APPROVING THE REQUEST OF THE TEMPE POLICE  
DEPARTMENT TO ACCEPT GRANT FUNDING FROM THE  
ARIZONA DEPARTMENT OF HOMELAND SECURITY AND  
AUTHORIZING THE CHIEF OF POLICE OR HIS DESIGNEE TO  
ACT AS AGENT OF THE CITY OF TEMPE FOR ALL  
NEGOTIATIONS AND NECESSARY INSTRUMENTS.**

WHEREAS, the City of Tempe, at the recommendation of the Police Department, will accept grant funding from the State of Arizona, Department of Homeland Security; and

WHEREAS, the project would fund equipment and supplies to improve public safety;  
and

WHEREAS, this project is for the benefit of all citizens of Tempe; and

WHEREAS, the project is compatible with the laws of the United States of America, Arizona and the City of Tempe.

NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF TEMPE, ARIZONA, HEREBY:

1. The request to apply for and accept grant funding from the State of Arizona, Department of Homeland Security, in the amount of \$130,000 is hereby approved.
2. The Tempe Chief of Police or his designee, is hereby authorized to act as agent of the City of Tempe to conduct all negotiations, execute and submit all documents including but not limited to applications, agreements, amendments, billing statements, and any other necessary or desirable instruments in connection with such grant.
