- B. The City has previously administratively approved amendments to the Schedule of Performance within the DDA, the last amendment dated September 13, 2007.
- C. The City and Developer desire to set forth their mutual agreement as to certain matters relevant to the DDA, subject to the terms and conditions set forth herein.

#### **AGREEMENT**

NOW, THEREFORE, in consideration of the foregoing and the mutual obligations of the parties hereto, the City and Developer agree as set forth below:

- 1. <u>Applicability of DDA</u>. With the exception of the provisions stated herein, all other provisions of the DDA shall remain in full force and effect.
- 2. <u>Schedule of Performance</u>. Effective upon the execution of this First Addendum, and without need for further action by any party, the Amended Schedule of Performance attached hereto as **Exhibit "B-1"** automatically shall be deemed to be substituted for the Schedule of Performance attached to the DDA as **Exhibit "B"**, and all references in the DDA shall be deemed to refer to the First Amended Schedule of Performance (**Exhibit "B-1"**).
