- **COMMENTS:** Pursuant to Intergovernmental Telecommunications Facilities Sharing Agreement No. 100502 and C99-238A, ("Sharing Agreement") entered into as of the 1<sup>st</sup> day of June 2002, the CITY OF PHOENIX and CITY OF TEMPE may enter into site-specific supplemental agreements to share facilities owned by and/or operated by the other. This particular agreement is for the sharing of a communications facility located at the South Tempe Police Substation. Phoenix and Tempe desire to share a communications facility constructed at the site for the purpose of expanding the Phoenix Regional Wireless Network (PRWN) and bring Tempe onto the network.

#### **RESOLUTION NO. 2008.11**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPE, ARIZONA, AUTHORIZING THE MAYOR TO EXECUTE AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF TEMPE AND THE CITY OF PHOENIX FOR A SITE-SPECIFIC SUPPLEMENTAL AGREEMENT TO THE INTERGOVERNMENTAL TELECOMMUNICATIONS FACILITIES SHARING AGREEMENT NO. 100502 AND C99-238A, FOR THE PURPOSE OF EXPANDING THE PHOENIX REGIONAL WIRELESS NETWORK (PRWN) AND BRINGING TEMPE ONTO THE NETWORK.

**WHEREAS,** the Cities of Phoenix and Tempe desire to further develop the joint Phoenix Regional Wireless Network (PRWN) by adding Tempe to the Network; and

**WHEREAS,** Intergovernmental Telecommunications Facilities Sharing Agreement No. 100502 and C99-238A allows the City of Phoenix and City of Tempe to enter into site-specific supplemental agreements to share facilities owned by and/or operated by the other; and

**WHEREAS**, the City of Tempe is authorized by A.R.S. §§ 11-951, et seq., and City Charter Section 1.03 to enter into this Agreement;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TEMPE, ARIZONA, as follows:

The Mayor of the City of Tempe is hereby authorized and directed to execute the Intergovernmental Agreement between the City of Phoenix and the City of Tempe for the South Tempe Police Substation (Supplement Agreement No. 3 – Amendment 1), on file with the City Clerk's office.

#### SUPPLEMENT AGREEMENT NO. 3 – Amendment 1 CITY OF PHOENIX INTERGOVERNMENTAL AGREEMENT 100502 AND CITY OF TEMPE AGREEMENT C99-238A FOR SHARING OF COMMUNICATIONS FACILITIES

Pursuant to Intergovernmental Telecommunications Facilities Sharing Agreement No. 100502 and C99-238A, ("Sharing Agreement") entered into as of the 1<sup>st</sup> day of June 2002, the CITY OF PHOENIX and CITY OF TEMPE enter into this site-specific agreement, which shall be Amendment No. 1 to the Supplemental Agreement No. 3 to the Sharing Agreement.

### 1. <u>SITE</u>

- 1.1. South Tempe Police Substation, located at 8201 S. Hardy, Tempe Arizona 85285 (Lat. 33-20-26.0, Long. 111-57-09.0). The City of Tempe, the property owner, grants Phoenix permission to use the existing property for the installation of 700/800 MHZ Trunked Radio Network transmitters, receivers, antennas and associated equipment identified in this supplement.
- 1.2. Phoenix constructed a communications site in 2002 under the original Sharing Agreement Supplement 3, which consists of a 13' x 36' communications equipment building, 150' monopole and Emergency Generator. This site supports the Phoenix PRWN network. To add Tempe to PRWN, additional equipment is being installed at this facility to support then new "Simulcast F" subsystem which will support Tempe radio operations. The equipment being installed by this project will be managed and maintained by Phoenix. Electro-mechanical and HVAC equipment installed at this communications site shall be managed and maintained by Phoenix.

#### 2. FREQUENCY USE

- 2.1. <u>Frequency Licensing</u>: As stipulated in the Master Site Sharing Agreement each agency is responsible for the proper licensing of operating frequencies utilized at this site with the Federal Communications Commission (FCC).
- 2.2. Frequency Protection:
  - 2.2.1. Phoenix shall be responsible for resolving interference problems generated by Phoenix owned equipment that affect existing frequencies employed by Tempe, and shall bear the cost of such resolution.
  - 2.2.2. Tempe shall be responsible for resolving interference problems generated by Tempe owned equipment that affect frequencies employed by Phoenix, and shall bear the cost of such resolution.
  - 2.2.3. Phoenix and Tempe shall ensure that they are operating telecommunications equipment at this site in compliance with current licenses issued by the Federal Communications Commission (FCC). In the event that interference issues arise with either parties equipment, and it is determined that the interfering party is in compliance with their FCC license, then both parties will cooperate and work together to equitably resolve the problem per established FCC guidelines.
- 2.3. Frequency Assignment:
  - 2.3.1. Phoenix
    - 2.3.1.1. The Tempe PD Substation site is an integral part of the PRWN Trunked Radio Network as a "Simulcast C Site," which consists of ten (10) 800 MHZ NPSPAC Channel assignments. Channel assignments/FCC licenses shall be maintained by Phoenix and are available upon request.
    - 2.3.1.2. This site is being expanded to bring the City of Tempe onto the network which requires the build out of "Simulcast F Site" subsystem that consists of fourteen (14) 700 MHz channels to be assigned by the Region 3 RPC and FCC.

Channel assignments/FCC licenses shall be maintained by Phoenix and are available upon request.

- 2.3.1.3. MICROWAVE FREQUENCIES:
   11.2 GHz to Tempe Butte (Tower Azimuth. 009.4°)
   11.2 GHz to Chandler Fire Training Academy (Tower Azimuth 147.9°)
- 2.3.2. <u>Tempe:</u> Tempe currently utilizes this facility to house their legacy trunked voice system. This system is being replaced by the PRWN Simulcast F subsystem. Once Tempe has fully transitioned to PRWN, the legacy voice system will be decommissioned and subsequent equipment removed from this facility.

- 3. <u>EQUIPMENT INSTALLATION</u>: Detailed site and equipment installation drawings are available from Phoenix upon request. Phoenix and Tempe will coordinate all proposed changes to this facility and ensure that all site as built drawings and equipment layout information are kept accurate.
- 4. <u>MAINTENANCE:</u> The Communications facility and PRWN equipment installed at this site shall be managed and maintained by Phoenix. All equipment provided by Tempe in support of Tempe operations shall be managed and maintained by Tempe. Tempe shall provide 24 hr/day access to the site by Phoenix personnel for preventive and corrective maintenance activities. Preventive and corrective maintenance performed by either agency that may affect the other agency's equipment or network systems shall be coordinated between the agencies prior to the start of work. Because this equipment supports Public Safety Operations, network service interruptions shall be kept to an absolute minimum.

All other terms and conditions remain unchanged.
