Agenda Item 1 - Approval of Minutes - December 5, 2007 Meeting

Agenda Item 4 – Update on the Western Canal Bike Path project

- 1. Both golf courses were approved for new equipment worth \$250,000.
- 2. Successful overseed at both courses positive comments from the public.
- 3. Raking bunkers on a daily basis with a machine.
- 4. This spring removing non-playable turf areas at Rolling Hills and transitioning to desert areas to save water.

Sam Thompson, Deputy Manager-Parks Services, Parks and Recreation Department, reviewed the recent totals for rounds and revenue.

1. The 4-6 days of rain took a hit on golf.

- 2. Rounds are improving at Rolling Hills, but for the calendar year the rounds at both courses are down.
- 3. The golfing industry is down as a whole. Robert Marshak presented an article titled, "More Americans Are Giving Up Golf" from the New York Times.

- 1. Need to work on policing slow play. Need to speed up play or will lose golfers.
- 2. Possibly establish and enforce a city policy to speed up play posted regulations.

- 4. What are the options of enforcing slow play currently?
