Q7. Are there any specific improvements that you would like to see the City of Tempe make in your neighborhood?

- Rental yards and appearance.
- More frequent street clearing and resurfacing as needed.
- I would like to see improvements made at Clark Park Pool.
- Our alley needs work. Clean up by city crews is good, but there are a few spots and holes that collect water, dusty, badly need gravel.
- We have an area by our trash containers where junk and boughs from trees are dumped. It is unsightly.
- Enforce more weed/nuisance landscaping issues.
- More control on weeds, etc. on private homes.
- Try better rat control in alleys and residences.
- Yes, weed control on both developed and undeveloped property. Needs stricter enforcement in order to keep Tempe the great place to live that it is. Thank you.
- Have renters take better care of yards.
- Old cement slab walls facing major streets deteriorating. Just had to borrow \$9,000 to replace my wall.
- More maintenance in the alley. More enforcement of zoning code with respect to private property.
- Lots of homes with students, lots of traffic and parties. Property starts to run down with students.
- Put in sidewalks on Curry Road east of Scottsdale Road. More street lights needed.
- Level and grade alleys. Put recycling pickup in alley.
- Street lights, more of them.
- Maintenance and improvements for parks. Policing for gang activity.
- Yes. Plumb to vertical street signs and light poles. This goes for Southern Avenue between Rural and McClintock. Leaning sign poles look tacky and cheap.
- Street lighting on the west side of Mill between Alameda and Southern. It is hard to see pedestrians at night. The existing lighting isn't adequate at the side street entrances.
- More frequent street sweeping, better tree maintenance on commercial property.
- Traffic calming on College Avenue, in process. Homeless and transient problem on Southern Avenue. Homeless and transient problem at library due to orbit. Bury the cables and phone lines.
- Yes, trees, weeds, grass need to be trimmed on private property. Alleys are an eyesore, weeds, debris thrown all over. Many sidewalks are cracking and in dire repair or to be recemented in front of owner's houses. Unsafe to walk on in many areas of my neighborhood, Meyer Park area.
- Would like the code enforcement like we had in 70's and 80's. For instance, cars parked in front yards, trailers, motor homes, parked in driveways and front yards. Repairing vehicles in driveways and vehicles not running in driveway.
- Rental signs (Advance Rental and Sales) on Dorsey are on rental property year round. Leads people to believe all property is rental here.

- Pave alleys, cut dust.
- Street lights. Speed bumps. Publish survey results on Internet.
- Stop dogs from running loose. Make dog walkers pick up after their dogs.
- Crime. Crack down on drugs at 400 W Baseline.
- The neighbors sharing the garbage receptacle in the alley won't walk to the next receptacle if mine is full to empty their trash. They just throw it in the alley. Can we put a bumper sticker saying, If full, please use another container?
- Pave the alleys. Arrest and charge people who do graffiti. Enforce laws for homeowners to take care of property.
- Alley maintenance and oiling.
- Enforce rental laws restricting number of people living in one residence. College students have 6 or 8 vehicles per house. Remove obstacles that block sight at corners.
- Green belts for walking. I wish there were parks or play areas closer. We can't visit a park without crossing a major street.
- Make rental houses take better care of their yards.
- Improve the neighborhood park.
- Street lights. More patrol.
- Not very happy about the signage at Tempe Market Place that is visible from the 202.
- Reroute the orbit bus. It is not needed and makes my neighborhood noisy, causes traffic and reduces quality of life.
- Street sign at beginning of cul-de-sac. Fix leaky drip systems.
- Quality of parks. More things to do in parks. Attract people to walk in neighborhoods.
- Street lights continue to burn out. They need to be replaced. Alleys are a mess.
- More street lights.
- Weed removal by neighbor sometimes not maintained.
- Someone should check on lawn care. A neighbor does not need to report a neighbor. That causes problems.
- People parking at corners.
- Control graffiti. Maintain infrastructure. Decrease ASU partying.
- There are some block walls at the entrance to Sierra Vista and at Broadway and at LaRosa and Broadway that look shabby.
- We're concerned over an unoccupied house that has an owner who regularly forgets or neglects the yard or condition of the home.
- Enforce dog laws. No animals unleashed. People who leave yard and home in poor condition.
- Be able to get into the park (Tempe Town Lake) to walk when there are large events. I do not feel safe walking in my neighborhood in the early morning and cannot get into TTL when large events are going on.
- Enforce speed limits in residential areas.
- Enforcement of rental codes. Too many cars parked on lawns. Clark Park looks at times like a homeless camp.
- Too many people let too many weeds grow. Enforce awful yard ordinance, if there is one.
- The corner of Scottsdale and Roosevelt has a Circle K and a Laundromat. The customers leave trash all over the place.
- Increase neighborhood lighting and routine police patrols.

- I wish there weren't so many rentals in our neighborhood, because neither the renters nor the owners maintain the front yards.
- The Neighborhood Enhancement Program does not go far enough in dealing with owners/renters who chronically neglect basic home improvement and landscaping.
- Stop urban sprawl. It is not working. Clean up Mill Avenue, make Tempe more family oriented.
- Bike lanes.
- Not pedestrian friendly.
- People parking on their lawn.
- Signs, slow kids playing or present.
- Poorly kept yards, too many people/cars in rental housing; too many cars/improperly parked cars/boats/trailers in driveways and side yards.
- Our alley has a 20' wall separating it from the freeway. It is pitch dark down there. I wish there were lighting in the alley.
- Yes, traffic lights need clock flashing. People know when lights are getting red, not running cross red light.
- More usable parks. Play structures. Skate parks. Basketball courts.
- Homeless are sleeping in an alley by the church. Moving too swift up the alley.
- Remove illegal advertising promptly. There are too many cars for sale, foreclosures, easy money, pool cleaning, etc. signs on right of ways. This cheapens the city. What code is enforced?
- Do not work on all north and south streets at one time.
- Install traffic calming solution to Alexander Avenue, between Rural and Mill Avenue. Traffic from Corona del Sol is very heavy.
- Citywide, less traffic law enforcement, speed cameras should be eliminated completely.
- No, we live in a terrific neighborhood.
- Better police patrols on side street.
- More police presence in my neighborhood. Condition of streets.
- Fix my water meter.
- I'd like to see them act faster on trashy carports, yards and cars that are parked on lawns, etc. that no longer run.
- Patrol more often at Daumler Park at Balboa and Evergreen. Lights in our neighborhood are very dim. Some people don't care for their property, which contributes to others' home values going down. Give those folks notices about caring.
- Pave alley. Set up no parking signs within 150 feet of all intersections. Cite, not warn, property owners who park broken down vehicles on property.
- Make landlords keep up rentals and yards.
- Police pull us over for no reason. They only do this because we are Hispanic. May God Bless you.
- I would like the recycling to be picked up in the alley. Also, control the dust in the alleys.
- Enforce variance requirements and code compliance with some residences. We have one house on the end who just does what they want without contacting city, uses front lawn as a parking lot and whose backyard is a disaster and safety issue as their fence is falling down.
- Asphalt in streets has been cracked for two years allowing rain to seep in.
- Fix cracks in sidewalks.

- Yes, I would like to see a limit of people living in a home that can be enforced. It seems that we have a problem. Anyway I can see that this is a problem in my neighborhood.
- Maintenance of private property. Limit number of rentals.
- Bus stops shaded and lit at night.
- Deal with unkempt rentals/empty houses, unkempt pools, etc.
- Revitalize Scudder Park (lighting, etc.). Speed bumps needed on Watson, Lakeshore to Rural.
- I would like to see better surveillance of and action toward shoddy houses, yards and pools.
- In July, we requested a street light cover over the light on Guadalupe directly behind our home because of how bright it is on our balcony at night. The work order was supposedly submitted, but never fulfilled.
- Pave the alley.
- I live in a mobile home park so a lot does not affect me.
- Yes, more road bumps (not signs) placed along College Avenue, south of the Post Office to the end near the freeway. People are traveling about 40-50 MPH. Very dangerous.
- Make homeowners take better care for homes and yards. Also, renters do not take care of yards. They are a disgrace on my street.
- The city should avoid overuse of traffic calming structures on College Avenue that are potentially damaging to cars and can make cars move from the center of the street into bicycle lanes. Specifically, roundabouts in intersections and football shaped center islands are things I personally would prefer not to have. A four way stop at College and Alameda should be adequate for calming traffic between Broadway and Southern.
- Increased police visibility/patrols in order to deter the increase in property theft and other crimes in our neighborhood.
- Speed bumps on Beck from Broadway north to 16th Street or other deterrent for speed reduction.
- Upkeep of vacant or foreclosed houses.
- Better lighting on College Avenue and east on Manhattan Drive. Unfortunately, people do not have money to put into maintaining their homes. Some rental houses not very desirable looking. Our homes are 40-45 years old. Poor landscaping and landscape maintenance.
- Include the county island property north of river into the city by whatever means necessary. It is an eyesore.
- We have a natural gas easement, alley in our neighborhood that is a dumping ground, ugly and a gathering place for drug users.
- Pave the alley.
- More police visibility in neighborhood.
- Enforce property codes with more determination.
- Control graffiti. Walkway from Grove Parkway to Elliot Shopping Center needs attention, policing.
- Have the occupants of all property (rentals included) be liable for appearance of yard, home and particularly alleys (some are pig sties). Levy a fine if necessary. So many owners just toss garbage, tree trimming, furniture, over the fence. Perhaps one of those large rubbish containers positioned at various locations would help enhance the appearance.

- Streets need to be repaved. Some alleys are tanned over, some are still dirt. Bus lanes to relieve congestion at intersections. Much retail space sitting empty, bring retail to core of city, away from ASU.
- Property maintenance.
- I am very disappointed in various building designs and landscaping requirements (lack of) near ASU campus, i.e. dorms at Apache and Rural, building at SE corner of McClintock and Apache, new apartments along Apache and West University.
- Rentals, especially used by college students, are a big problem. Yards are run down and often at least five or six cars are on the property and along the street. Restrictions on no more than three unrelated persons in a home are not enforced.
- Neighbor lets trees, etc. grow out of control. The only house in the neighborhood that looks shabby.
- Enforcement of number of vehicles parked at a residence.
- Keep light bulbs replaced in parks. Pole lights at entrance of Kiwanis Park off Baseline near railroad tracks on hill always out.
- Could you possibly pave the alleys?
- More control of rental properties, appearance and noise and cut through traffic. More enforcement of no right turn on LaJolla and Rural.
- Traffic calming.
- Fix sidewalks along Mill (at least between Broadway and I-60 on east side).
- Make rental property owners more responsible for the appearance of the outside.
- Stop light for pedestrian crossing somewhere between Freeway and Southern on Rural. I only walk or cycle, no auto. How can I cross on Rural at Laguna to get to library, etc.?
- Repave street, increase water pressure, paint street light poles.
- Reduce and/or restrict excessive curbside parking. Most is a result of auto maintenance projects.
- Get rid of the HOAs. They try to run your life and have no right to.
- Good service.
- Keep high quality streets, forget traffic calming ideas.
- Enforcement of timeframe for putting out articles for large item pickup.
- We have found lots of support from the city in planning neighborhood activities.
- Upgrade the park, move out the soccer fields.
- Fix the stucco; appearance of the outer wall.
- More alley clean up and large item pickups.
- Lower taxes on homes and property.
- Make our neighbor finish remodeling of house and stop parking in his front yard and clean the back yard.
- Some of our neighbors are complete slobs. The LDS Church at Lakeshore and Gemini allows local high school students to congregate and leave trash all over the neighborhood. No code enforcement evident.
- Eliminate election signs, very ugly and too many.
- Better lighting (all lights on College are at alleys between Alameda and Southern). Better code enforcement and encouragement for owners to upkeep property. Utility improvements, specifically under-grounding of electric/phone/cable TV lines.
- Housing/occupancy codes. Rental properties seem to have too many people per rental.

- The traffic islands on Mill Avenue between Elliot Road and Secretariat Drive have had at least three trees die and not replaced.
- Policing Villas Las Palmas Pool area.
- Irrigation of adjacent school property brings terrible smell and mosquito problems. Alley traffic raises dust all the time.
- Enforce whatever codes the city has for homeowners/landlords to maintain their property so weeds/junk cars aren't devaluing the neighborhood.
- Shade screens for playgrounds.
- Clean dirty canal.
- More street lighting, slow traffic.
- Crack down on graffiti, and weedy yards.
- More Orbit routes/frequency. They are awesome.
- Orbit Bus service.
- Downtown Tempe is not my neighborhood but I have received comments from other women while we were in Downtown that they are uncomfortable with the vagrants and people hanging around asking for money. It's a deterrent versus draw to the business on Mill Avenue.
- Police coverage, we have quite a bit on teen hoods who like to race their cars and terrorize our parks and community pool area.
- Alisanos Community Association needs training in the areas of landscape, and water conservation. They waste all of our money trying to achieve unrealistic goals, i.e. perfect lawns in September.
- Better enforcement of codes. Too many neighbors getting away with non-maintenance of houses, yards, trees, etc.
- See that the home owners take better care of their property, weeds, etc.
- Streets are very dark at night. More light would make the streets feel safer.
- Private property maintenance. Get rid of traffic calming devices, especially temporary ones.
- Speed humps.
- Continue to improve the county island that's now Tempe along Carver and Rural. They have crummy yards and needs facelift. Common areas along streets need landscaping.
- Put in bicycle lanes on West Baseline Road.
- I would like to see an improved shaded table area.
- Enforce its own bylaws regarding junkyards/bird/dog raising in backyards. City inspector is useless.
- Lay additional gravel in the alley to eliminate standing water and muddy conditions.
- We rated #6 good but we have one exception because of one house directly across from us. The yard is a mess. Grass and plants all dried up from neglect and pigeons roosting on the property.
- Remove soccer from neighborhood park (Goodwin Park). Soccer parents are oblivious to residents, blocking traffic, turning around in driveways and blocking driveways. Over use of the park leaving large bare patches in the grass not giving it a chance to grow back.
- Keep weeds cut. Suggest businesses identify their property with numbers readable from a moving car.
- Move the light on Elliot from the canal to Mill. It is often very difficult to turn on Elliot and the light at the canal serves practically no one.

- Tree maintenance. Slow down traffic in neighborhood.
- More traffic control measures.
- Provide police patrols. Haven't seen a squad in the neighborhood in three years.
- How about keeping rentals or neighborhood homes cleaned up, i.e. tall grass, grass growing in rocky areas, dead trees, etc.
- Crack down on run down properties. Crack down on gang activity, homeless loitering, illegal drug selling, prostitution, and parking.
- Block bicycle bridge in neighborhood it is an intrusion and waste of money.
- Feeling of safety.
- Better drainage of streets. Corner of University and McClintock floods when it rains heavily.
- Some homes and yards are a mess and need to be cleaned up.
- The condition of rentals, controlling disgusting alleys. Noise control, constant barking dogs, loud parties (college kids in rentals).
- Street sweeping.
- Yes, force HOAs to plant grass throughout subdivisions, not only perimeter lawns.
- Make sure section 8 homes are kept up.
- Home mail delivery (I am a disabled veteran).
- Spray olive trees.
- Fences that face the streets. Get people to visit Tempe.
- Speed bump from Cornell/Wilson to McKemy/Colgate. This stretch is a haven for teenage speeders and includes a blind intersection at McKemy/Fordham, right across from two elementary schools. Weed control poorly enforced from Baseline to Guadalupe Roads and Kyrene to Hardy Road on private properties. Traffic signal needed at Kyrene/Cornell intersection.
- Some kind of law or rules on front yard maintenance. One out of 8 houses or so a family of pigs moves in.
- I really wish there were a bathroom at our neighborhood park.
- Remove the speed bumps.
- Finish paving from Priest to 48th Street. Also paving of Southern East from Priest to 101. Four years is too long.
- New street light at 530 W 19th is not bright enough.
- With the rail starting up, we need some more police protection around McClintock and Apache area.
- Make people clean their front yards/junk cars.
- Get stricter on landowners to not neglect houses and lawns they are renting out. Notify neighbors who are letting their trash spread in alley (like my neighbor).
- I don't always see the street sweepers come. Don't know how often they come but it would be nice to see them sweep a little more often.
- Speed bumps.
- Homeless and drugs. Too many college rentals with cars in driveway and slum looking. Too many empty stores.
- Keep up alleys like streets, parks like front yards with shrubs, flowers and shade trees and enforce existing zoning, site plan and use regulations.

- Enforce codes as much as possible, ticket those who park backwards (facing wrong way) on city streets, help us to keep loud and late partying to a minimum, always remember that Tempe does not end at Price Road.
- The city should not allow demolition of areas downtown before the developer has firm plans for construction.
- Closer Bark Park for dogs.
- Get moving on Scudder Park.
- Dog park area in the local park. Bike paths in Tempe Market Place. Bike paths through neighborhoods, so we don't have to ride on busy streets.
- Traffic control on South County Club way.
- Work with homeowners to improve curb appeal. Quality of yards and how many animals and what kinds are allowed in residential housing.
- Trim trees.
- Take out the speed camera. Seems all it does is to collect revenue.
- More green and more police in the neighborhoods.
- Improve neighborhood quality of code violation enforcement.
- Hold homeowners accountable for renters of their property.
- Reduce cycle failures in left turn lanes on Apache Blvd. And start using vehicle sensors at the intersections that will actually detect motorcycles.
- Our alley is not paved and the dust is awful.
- The police force may be a bit too abrasive, as influenced by the Sheriff's office. Police should understand constitutional law as part of their training.
- Stop light between Ray and Warner on Priest.
- Many of my neighbors don't take care of their yards. I would like to have the city enforce rules about removing weeds when they get completely overgrown.
- Continue code enforcement on private property, occupancy and appearance. Put some shade in the play area of Indian Bend Park.
- I would like to see the city maintain road side landscaping and enforce weed growth, etc. at private residences. It makes our neighborhoods look trashy.
- I'm lucky to live in the Eden area.
- Signs for traffic to slow down for children, or more speed bumps to slow traffic.
- Enforce shrubbery and tree trimming so that oncoming traffic (especially intersections) and street signs can be seen more clearly.
- Street lighting is poor. What happened to the city wide wi-fi computer connectivity?
- Do away with the hideous blue trash barrels and enforce yard clean ups.
- Yards are not maintained or inspected often.
- Underground power lines.
- Make residents put blue barrels away.
- Clean and streets repaired.
- Speed hump for east 8th Street/Hayden Lane. More street lights for East Hayden Lane.
- Homes zoned for single families should not be rented to 5-6 college kids. Properties look like hell and the parties and the break-ins.
- Limit and reduce the number of rental properties. Crack down hard on all property owners who will not maintain their homes. There are so many sloppy looking properties, it has to hurt the quality of people willing to move into Tempe (not to mention the home values).

- Drop the sales tax on food. You've just doubled it.
- Lighting, party (college student) management.
- The city has caused substantial damage to my fence because of poor watering in Stroud Park. They need to fix the fence (they recently changed the watering patterns in the park).
- Definitely clean the alleyways of grass and debris, especially grass and weeds. It doesn't seem to be cleaned at all.
- Asphalt alley. More aggressive with rental laws and codes. Better blight enforcement. Improve storm sewer capability, street floods.
- Address slummy houses and slum rentals in the three mile radius of ASU, Priest to Dobson, 202, Baseline.
- Focus on areas that need renovation.
- Work with Cox to move the cable TV control box in the alley which keeps getting hit by city trucks. Enforce tougher laws against gangs and criminal activity, burglaries, homeless and prostitution.
- Parking for Esquer Park and public restrooms for the park, more involvement by Park Rangers. Enforcement of city codes for private property.
- Make people take better care of their yards front and back.
- Restrooms at Meyer and Hudson Parks.
- Stronger ongoing code enforcement.
- Replace white stop signs. Make school zones more evident, use blinkers. Speeds should be 35 when in session. Other towns do this and use motion sensors to turn on street lights. Help us with student occupied houses.
- Get with our HOA, and see if they can paint our units. The paint is chipping and the fences are also looking bad.
- The city telling residents who do not keep up property appearance to do so.
- The alleys, they need to be cleaned and scraped along fence line and most of all they need to oil or tar to keep the dust down to a minimum. Also get rid of weeds and make home owners or rentals use the dumpster, not just throw over fence.
- Seal coat our streets.
- More patrols through our surrounding property to cut down on graffiti which has increased greatly this year.
- Upgrade and repair street lights, painting of common visible fencing at brick walls. Keep grass and plants groomed.
- Replacement of olive trees on Rural Road behind my house. I was told they would be replaced in two years and that was 8 to 10 years ago.
- I'm so sick of picking up dog poop on our front lawn from other people's pets.
- Everything.
- Discipline the neighbor that throws her garbage in front of my house please.
- Consideration of stop signs on Lakeshore south of Elliot or speed bumps on same. There is too much speeding and racing.
- Corbell Park needs improvements. More trees, playground equipment, cover for play area (shade). The condition of the playground at Corbell Park is deplorable. It is worse than it was 23 years ago when we first moved here.
- More maintenance of shrubs along McClintock Drive. It is getting dangerous and restricts visibility of oncoming traffic.

- Stones or pavement in alley like other alleys in Tempe. My house just has dirt in the alley.
- Speed bumps from Elliot to Dava on Lakeshore Drive.
- Enforce yard maintenance/pool maintenance.
- A few more street lights, upkeep on street name signs, police patrols more often.
- Slow traffic speed on my street by adding speed bumps. Enforce 35 mph zones at all times. Don't like sodium (yellow) street lights. Are there alternatives, especially on residential streets?
- Better control over rental property.
- Some potholes in alley behind my house have been there a long time since a leak occurred in some pipes under the road. Pipes not on my property.
- More police cars during weekends and daylight hours.
- Remove graffiti. Make the neighborhood safer by presence of the local police.
- Add a public gardening space. Require solar panels on all new public buildings and apartment/condo buildings.
- Fix potholes and sidewalks.
- Clean up abandoned property off of Farmer and 1st Street, parallel to the railroad tracks. There have been fires, auto break-ins, destruction of real and personal property. There is excessive drunkenness, killings along 1st Street and Farmer and vandalism.
- Right now, the streets are being resurfaced. Same with our neighborhood park.
- On the west end of Hanger Park, fix existing lights or add additional lights.
- Dog leash laws, rotten condition grass in the park. Get rid of moldy smell in the library. Clark Recreation has smelly carpet, needs renovation.
- Condition of alleys.
- Clark Park. Clean alleys.
- Private property maintenance.
- Better ordinances for noise/fast traffic on residential streets. Trashy yards, multiple 4+ cars at one house.
- Limit the population of Tempe.
- Weeds growing in street. Alleys are very dusty when garbage truck comes through. Saving historic places around Tempe.
- Too many cars always parked on the streets.
- Enforce existing codes on rental houses. We have many rentals which we turn in for code violations, and the city does not do much as we are told the city does not have the time to pursue each violation.
- Repair or replace trash containers in alley.
- We would like to see the improvements made to the canal for a multi-use path that have been planned for some time.
- Do not allow lawn parking, junk cars in driveways, unkempt lawns and front yards.
- Alley maintenance. Help homeowners replace old, broken, ugly, out of date fences.
- Don't add more traffic to streets, i.e. Walmart coming to area. Not a good addition.
- So many people throw everything in the alleys. Because of where our house is, we have to look at it. Also, there are a lot of rentals in our neighborhood. A lot of the rentals are not kept up and actually have trash in the front yard.
- More police presence.
- Street light at Lamplighter, dark at night.

- Better police.
- More lighting in neighborhood, clean up vacant lots and nicer entrances into neighborhoods.
- Enforcement of maintenance of private property. Rentals are not kept up. Looks slummy.
- Less dust and dirt from alley. Weeds along street fences pulled.
- Do some planting to beautify the area.
