Agenda 1 - Consideration of Meeting Minutes, May 5, 2008 (Motion Required)

Agenda 2 - Monthly Activity Reports for June and July 2008.

Teri stated the 2007/2008 year end statistics showed a 6% increase in door count with over one million people visiting the library. The statistics also showed a 1% increase in circulation, a 14% increase in public computer usage and a 14% increase in program attendance.

Teri also mentioned the month of July showed a continued increase in door count, electronic database usage, computer usage as well.

Agenda 3 - Library Remodel Update

Teri showed the Board a PowerPoint presentation on the library remodel project. She informed the Board that everyone was very pleased with the architect's willingness to implement design suggestions provided by staff. Teri commended Engberg Anderson on their ability to interpret the initial concepts and turn them into something dramatically different and exciting. Another public meeting will be held as soon as the schematics are finalized.

Agenda 4 - Summer Reading Program Results

Teri shared statistics on various summer programs held at the Library and Escalante such as: the first Adult Summer reading program, and the children's and teens reading programs. All of the programs were very successful this year in terms of participation and attendance at programs..

Agenda 5 - Mayor's Ad-Hoc Budget Committee Recommendation

A recommendation to increase the Collection Agency fee from \$10 to \$20 dollars, was approved by the Committee. This change will become effective September 1, 2008.

Agenda 6 - Libraries Connect Communities: Public Library Funding and Technology Access Study.

Teri reviewed a recently released study published by the American Library Association. This study highlights the role the library continues to play in providing free access to computers and the internet. It also shows that other libraries are in the same situation regarding flat funding, staffing levels, building infrastructure needs to support technology requirements., etc.

Agenda 7 - Friends of the Tempe Public Library Report

Sam Stratton was re-elected as president for next year. Sam continues to develop the Board. Monthly revenues provided by the Friends book sales average at approximately \$4,000.00 per month. The Friends have committed nearly \$50,000 in support of the library to Connections Café and Experience Corps. The Library received \$16,000 in support of the online Live Homework help tutoring system and the Experience Corps project received \$18,000 from the Tempe Diablos, thanks to the support of Friends Executive Board member and Tempe Diablos member, Arnold Davis.
