**Agenda Item 1 – Call to order**

Paul Hubbell called the meeting to order at 5:15 p.m.

**Agenda Item 2 – Approval of Nov. 14 Commission Minutes**

**Agenda Item 3 – Cultural Services Director's Report**

- Jody Ulich announced that the Tempe Center for the Arts (TCA) is full of activity; multiple groups are playing host to holiday events at the TCA.
- Ulich confirmed that the National Football League (NFL) has secured a full-facility lease for the TCA for about one week in January. The NFL is playing host to a private, evening event at the TCA related to Super Bowl XLII.
- Ulich stated that the TCA is playing host to its first wedding reception taking place on Dec. 29.

- Ulich affirmed that the TCA is receiving positive feedback from the public in regards to its facility leases.
- Ulich stated that the proposed Tempe Symphony Orchestra (TSO) TCA ticketing protocol is as follows: guests will be handed a ticket as they arrive to the TCA Theater. Tickets will not be assigned in advance.
- Shirlee King inquired about the possibility of overflow TSO seating in the TCA Lobby; Ulich stated that TCA Lobby overflow seating is available for any TSO performance taking place at the TCA.
- Nancy Goren inquired about a news article addressing Childsplay's revenue goals. Ulich stated that although this is Childsplay's third best season, Childsplay did not meet its 2007 sales projection.
- Ulich thanked the Tempe Municipal Arts Commission (TMAC) for its support throughout her tenure with the city of Tempe.

#### **Agenda Item 4 – Chairperson's Report**

- In the absence of the TMAC Chair, Scott Burge, Paul Hubbell thanked Ulich for her leadership and services as the director of the city of Tempe Cultural Services Division.

- Betsy Fahlman announced that the Hudson Park Panel selected artist Mary Lucking to install a public art piece in Hudson Park. Fahlman stated that the panel is interested to see how Lucking will engage the area around the park's meditation maze.

- Linda Sleight inquired about the Friends of TCA memberships. Sleight is concerned that the Gold (Individual) Membership monetary requirement may be too high. Sleight added that the Tempe community members who view the membership as being too costly may feel removed from the community aspect of the TCA.

- Scott Essex asked Sleight to provide a dollar amount for the Friends of TCA Gold Membership; Sleight stated that a \$50 monetary requirement would be a realistic request.
  - Kate Hanley expressed an interest in establishing a student and retiree Friends of TCA membership; Hanley added that a student or youth membership may better connect community members to Childsplay.
  - Essex stated that he would act as a communication liaison between the Friends of TCA and TMAC.
  - Hubbell stated that Tom Canasi, city of Tempe Community Services Department Manager, will attend the January TMAC meeting and share his vision for the city of Tempe Cultural Services Division.
