Agenda Item 1 – Call to Order

Lisa Morley, Committee Member and acting chair, called the meeting to order at 5:05 p.m.

Agenda Item 2 – Tempe Center for the Arts update

- Sally Garrison provided a brief update on the operation of the Tempe Center for the Arts (TCA) during its first year. A PowerPoint presentation will be presented by Don Fassinger at the Tempe Municipal Arts Commission (TMAC) meeting this evening. The presentation will outline details of first year activities at the TCA.
- L. Morley inquired about the TCA meeting revenue expectations. S. Garrison indicated that, in its first year of operation, the TCA surpassed revenue expectations. D. Fassinger explained that an unanticipated special event heavily impacted the revenue total for the year.
- Frank Williams inquired about pursuing Insight Bowl and Fiesta Bowl events. D.
 Fassinger indicated that an Insight Bowl event was held at the TCA in the past
 and another is scheduled for the coming season. Fassinger further explained that
 the TCA staff does not actively pursue large-scale events due to date availability
 limitations in the calendar. However, TCA booking information is widely
 distributed to contacts of major events and other event planning services.

Agenda Item 3 – TCA Partner Update

S. Garrison presented TCA Partner Program application materials and supporting documents from CONDER/dance for committee review. A motion for approval was initiated.
