- Nancy Goren stated that all panelists are considered to have a conflict of interest with an applicant organization if the panelist benefits financially or otherwise from the proposed project up for review.

- N. Goren invited the panel members to silently assign numerical rankings for each arts project grant applicant.
- All discussion commentary was recorded by Rachael Peterson.

Sondra Moore stated that it was her observation that many of the 2009 – 2010 Arts
Project Grant Applications lacked evaluation tools. Moore recommended that a sample
evaluation tool become part of the city of Tempe Arts Project Grant Application.
