# Agenda Item 3 – Consideration of Minutes: March 5, 2008 Meeting

#### Agenda Item 4 – Discussion of Group Home Regulations

For information only. Shauna Warner presented information on group home regulations. Group homes must comply with City codes and ordinances but are regulated by the State. The homes must be licensed by the State and adult/elderly assisted and foster care homes can not be located closer than 1200 feet from another home. Developmentally Disabled homes do not have the separation requirement but are still required to comply with building safety occupancy requirements and state licensing requirements. All of these homes are licensed by the State of Arizona and complaints and or questions from residents regarding the operation of facilities can be addressed to: Assisted Living Licensing, 150 N. 18th Avenue, 4th Floor, Phoenix, AZ 85007.

#### Agenda Item 5 – Update on Mobile Home Relocation Policy & Hot Team Members

Invite speakers to NAC meetings for more help in identifying what consumer wants.
