Agenda Item 1 – Call to Order

Chair Kaesberg called the meeting to order at 5:35 p.m.

Agenda Item 2 - Public Comment

There was none.

Agenda Item 3 – Consideration of Minutes: August 6, 2008 meeting

The August 6, 2008 minutes were considered for approval. Vice Chair Wasko moved that the minutes be approved as submitted. Commissioner Wilson seconded the motion. The motion passed unanimously.

Agenda Item 4 – Modifications to Residential Permit Parking Program

The Codes Committee reported on their discussion of the Residential Permit Parking (RPP) Program at the August 21, 2008 committee meeting. Concerns were expressed that the intent of the RPP were not being met in single family neighborhoods, especially those with mulit-family dwellings. Commissioner Ellison moved that the Neighborhood Advisory Commission forward the following change to the Residential Permit Parking Program to city staff and Mayor and Council:

The purpose and effect of The RESIDENTIAL PERMIT PARKING PROGRAM is to reduce and restrict parking on the streets where parking is allowed.

Only single family homes will be considered for up to 2 parking permits. Additional permits would be available for purchase by resident family members (Z &D 2-107;3-102;and 7-107) for additional vehicles.

Permits would be matched with residents residing in the single family homes by vehicle and rental or lease agreement.

Commissioner Wagner seconded the motion. The motion passed with a vote of 11 in favor and 2 against. Neighborhood Services staff will forward the recommendation to Traffic Engineering staff and Mayor and Council along with an explanation of the concerns the recommended changes address.

Agenda Item 5 - Explore Volunteer Group to Assist Residents with Code Issues

The Commission discussed potentially organizing volunteers or identifying existing volunteers and volunteer groups to assist Tempe residents in need with resolving code issues. Chair Kaesberg turned the meeting over to Vice Chair Wasko. Chair Kaesberg moved that the issue be referred to the Outreach Committee, Commissioner Knudson seconded the motion. The motion passed unanimously.

Shauna Warner briefly emphasized the importance of treating each Committee meeting like a Commission meeting in terms of following the Open Meeting Law. Specifically, agendas must be posted, all discussions must pertain to agenda topics and five person committees require a quorum of three members to take an action such as forwarding recommendations to the full Commission for consideration.

It was stated in the policy document that "The specific parking regulations for an area (hours and days of enforcement, special conditions, etc.) will be established to most clearly reflect the wishes of the residents who are being served." The policy document was seen as conflicting in that it referenced the Tempe Z &D Code section 2-107:3-102 and 7-107.

A motion was made and seconded and voted unanimously in favor of recommending a change to the policy as follows:

The purpose and effect of The RESIDENTIAL PERMIT PARKING PROGRAM is to reduce and restrict parking on the streets where parking is allowed.

Only single family homes will be considered for up to 2 parking permits. Additional permits would be available for purchase by resident family members (Z &D 2-107;3-102;and 7-107) for additional vehicles.

Permits would be matched with residents residing in the single family homes by vehicle and rental or lease agreement.
