Agenda Item 1 – Call to Order

Chair Kaesberg called the meeting to order at 5:30 p.m. without a quorum

Agenda Item 2 – Public Comment

There was none.

Agenda Item 3 – Consideration of Minutes: September 3, 2008 meeting

A quorum was reached at 5:35 p.m. The September 3, 2008 minutes were considered for approval. Commissioner Calender moved that the minutes be approved as submitted. Commissioner Wagner seconded the motion. The motion passed unanimously.

Agenda Item 4 - City Recycling Efforts

Mary Helen Giustizia gave an overview of the City's expanding recycling efforts and programs for residents and at City buildings. The City has increased the number of neighborhood drop off recycling sites to six. These sites are one way for residents of multi-family communities that do not have onsite recycling to participate. Since April 2008, 20 complexes have been added bringing the total served to 36 representing over 3,000 units.

The City also hosts and participates in a number of recycling related events to educate residents on the importance of recycling and what can be recycled. Plastic items #'d from 1-7 are now accepted in blue recycling bins and many special events now feature modified blue containers with special openings that accept only soda cans and water bottles to encourage recycling by event participants. A Green Waste Pilot Program is also being researched and explored as 60% of the monthly pickups for uncontained trash are made up of green waste such as grass and plant clippings.

Popular recycling themed programs include twice annual Shred-A-Thons, the ongoing Nike Reuse A Shoe Program and the roll out of ERIC, a portable Education, Recycling Information Center designed to educate students on recycling principles and practices to instill the importance of recycling early.

<u>Agenda Item 5 – Discussion of Potential Neighborhood Workshop Topics</u>

The Outreach Commission met on September 23, 2008 and made a recommendation that Mr. Rypkema be the Neighborhood Workshop and Awards guest speaker. Commissioner Wagner made a motion to approve Mr. Rypkema as the Neighborhood Workshop and Awards guest speaker. Commissioner Hall seconded the motion. The motion passed with 11 ayes, 0 nays and 2 abstentions. The Commission suggested that the committee work with Mr. Rypkema to have him also teach a workshop. They also suggested indoor and outdoor static displays of other City departments, i.e. the Police and Fire Department.

Agenda Item 6- Discussion of the Neighbor of the Year Awards
