ADDITIONAL INFO: The Housing Services Division has revised the Administrative Plan, last revised and

passed by Council on July 17, 2008. The current revisions are due to changes in federal regulations and administrative policies. The most significant changes have been to the model of the plan in addition to improving access to services for persons with limited English proficiency (LEP) and terminating the assistance of domestic violence, dating

violence, or stalking victims and perpetrators (VAWA).

In addition to the Section 8 Administrative Plan, revisions have been completed in the Family Self Sufficiency Action Plan and the Resident Advisory Board Policies and Procedures. All plans are mandated by the Department of Housing and Urban

Development (HUD).

The Resident Advisory Board has reviewed the Plans. No comments were submitted.
