Agenda Item 1 - Consideration of Meeting Minutes

Agenda Item 2 – Public Appearances

Greg Ellison (resident) proposed the Commission consider limiting the number of permits allowed to residents living in residential permit parking neighborhoods to three per household. There is currently no limit.

Agenda Item 3 - Proposed Bus Service Changes December 2008

Greg Jordan and Sue Taaffe provided the following information:

- Transit is proposing numerous bus route changes to integrate the bus system with light rail.
- The City of Tempe is administering a public involvement process spanning May –
 September 2008 to obtain as much public participation as possible in the development of these changes.
- Marketing is communicating the proposal via water bill inserts, the City of Tempe web site, Arizona Republic articles, posters on buses, Phoenix open house, and Press releases.
- There will first be a public comment period from May 27th to June 24th, and a public hearing on June 10th 2008.
- Staff will review public comments between June 25th and July 21st followed by a second public comment period between July 22nd and August 19th.
- City staff will review additional comments August 20th through September 3rd and a presentation of the final changes will take place at the September 9th 2008
 Transportation Commission meeting.
- Approved changes will take effect December 29th 2008.

Jayson Matthews opened the floor for public comment on item three only. Barbara Stockford (court reporter) recorded public comments to be available by June 30th 2008.

Agenda Item 4 - Tempe South High Capacity Corridor Study Update

Marc Soronson with Valley Metro provided the following information:

- There will be public hearings held on June 10 2008 as well as June 11 2008 to present the Tempe South High Capacity Corridor study
- Tempe and Chandler are working with METRO in coordination with the FTA on a two year study to analyze potential high capacity transit improvements.
- The tier one evaluation process is designed to eliminate alternatives that do not meet the project goals and is nearly complete.
- Tier two will consists of alternatives recommended for further study.
- Tier two is analysis is expected to occur over the summer and into the fall, with public meetings expected before the end of 2008.
