# Agenda Item 3 - Bike Events

Tanya Chavez informed the Committee of the following:

- Walk To School Day will commence on Wednesday October 15, Press Release included.
- The new Tour de Tempe art-info postcard for the event on Sunday October 26. The first 800 participants will receive at free T-shirt. T-BAG also updated the Committee on Tour De Fat Bike Event (October 11<sup>th</sup>)

## Agenda Item 4 - College Avenue & Maple Ash/ Mitchell Park East / West Traffic Calming

Eric Iwersen informed the Committee on the following traffic calming testing updates:

- Traffic Calming testing is a work in progress as the test phase will commence until November 2008. Maple-Ash (began in September 2008), College Ave (begins October 2008); Resolving community comments and problems with existing demonstration calming features will continue, and gather data for future permanent installations. College @ Alameda and College @ Encanto improvements are known as 'simulated traffic circles'. Rebecca Clark recommended using a "yield to bikes" sign at the traffic circle locations.

#### Agenda 5 – Bikestation

Eric Iwersen informed the Committee that the Bikestation operations contract planning is proceeding. The city will be releasing an RFP (plus pre-submittal conference) as early as October. At a minimum, the contract will require that the bidder entity be able to operate/manage the Bikestation bike parking program located within the Tempe Transportation Center. An option for sales/vending/rentals will be open to the bidder as a part of the contract. Selection and award of the bidder will occur in December 2008 or early January 2009.

#### Agenda Item 6 - Light Rail Update (inc. Tempe South Corridor Study, Station Area Design)

Dawn M. Coomer informed the committee that staff was continuing with Tempe South Corridor Tier 2 study. The next round of public meetings will occur on Tuesday December 9<sup>th</sup> at Desert Breeze Community Center in Chandler (6pm-8pm) and on Wednesday December 10<sup>th</sup> at Tempe Public Library – Community Room (6pm-8pm).

# Agenda Item 7 - Other Project Updates

Eric Iwersen informed the Committee on the following traffic updates:

Tempe Canal Path: project began construction in September 2008.

**Rio Salado (South Bank) Path**: project is under construction and anticipated to be complete December 2008, with soft opening in October 2008.

**Western Canal Path:** project is anticipated to begin construction on 6 miles of pathway in October 2008, however a request to lower the lighting requirements in order to lessen the light poles footprint is pending with the City.

Downstream Dam (West) Bridge at town Lake: Funding Obligation was received.

Crosscut Canal Path Update: A public meeting will occur in Oct-Nov or December.
